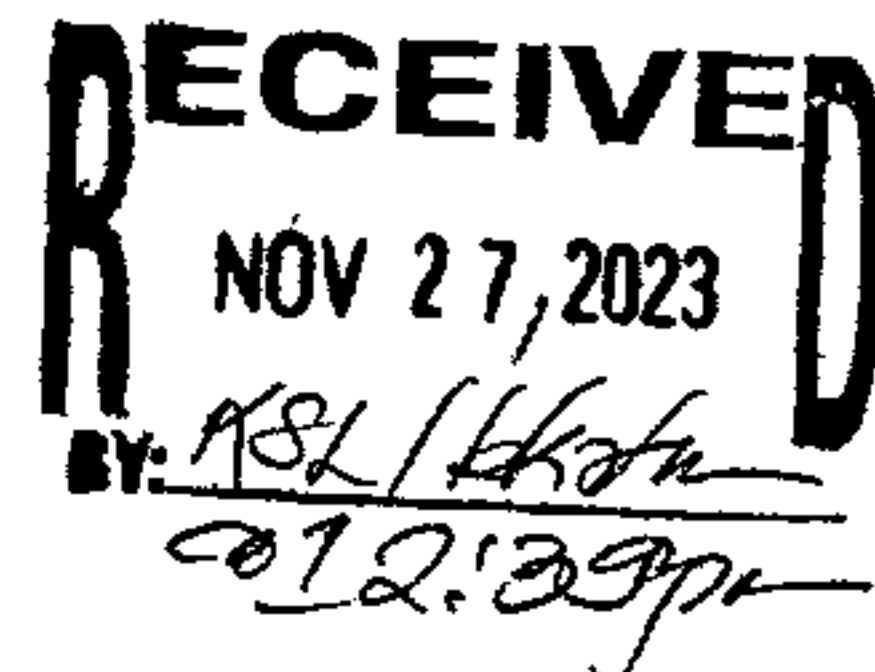

A BILL FOR AN ACT

To amend State Law No. 13-37, by amending Section 4 at subsection (d) to modify the Kosrae State Legislature's FY2024 first quarter approved budget for Consumables; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1           Section 1. Purpose. The purpose of this Act is to amend State Law No. 13-37, by  
2 amending Section 4 at subsection (d) to modify the Kosrae State Legislature's FY2024  
3 first quarter approved budget for Consumables; and for other purposes.

4           Section 2. Amendment. State Law No. 13-37, Section 4 at subsection (d) is  
5 hereby amended to read as follows:

6           "Section 4. Apportionment. Operation of the Legislature. The sums apportioned by  
7 Section 3 of this Act are apportioned as follows: ...

14           Section 3. Effective Date. This Act takes effect upon the approval of the Governor  
15 or upon its becoming law without such approval.
