

A BILL FOR AN ACT

To further amend State Law No. 12-136, as amended by State Law Nos. 12-141; 12-171; and 12-173, by amending the lapse date for funding under Section 12(10); and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

- Section 1. Purpose. The purpose of this Act is to amend State Law No. 12-136 by amending the lapse date for funding under Sections 12(10) of the FY2022 Budget. 2 Section 2. Amendment. State Law No. 12-136, is hereby amended as follows: 3 "...Section 11. Appropriation. The sum of \$877,525, or so much thereof as may 4 be necessary, is appropriated from the Amended Compact Fund of the Kosrae State 5 6 Treasury for the purpose of funding certain Governmental programs, grants, and contributions for the fiscal year ending September 30, 2022, provided that Section 12(10) 7 is extended and shall be lapsed on September 30, 2023. 8 9 Section 12. Apportionment. The sums appropriated by Section 11 of this act is 10 apportioned as follows:
- Amended Compact Fund Rev. Fund U.S. Grant Fund Forgn Asst. Fund
- 13 (10) DREA Giant Clam Reseeding Expansion \$88,640
- Section 3. <u>Effective Date</u>. This act takes effect upon the approval of the Governor or upon its becoming law without such approval.
