A RESOLUTION

WHEREAS, the late Nena S. Nena was born on the 15th of September, 1949 and called 1 2 to his eternal rest on his birthday, September 15, 2021 at 2 AM at Saint Joseph's Medical Center 3 in Tacoma, Washington; and 4 WHEREAS, the late Nena S. Nena was born to Sru Aliknena Tilfas of Isre, Utwe and 5 the former Tulpe Inteliki Isaiah Benjamin of Utwe Mah and was one of fourteen (14) siblings 6 which include Aliksa Killin (traditional adoption), Adalma Jacob Lonno, Angkela Nena 7 (deceased), Sepe Ned Freddy, Juslynda Willer Thomas, Senioline Sidney Skilling, Seniolina 8 Alexander Sigrah, Notwe Jack Asher, Engar Nena, Asma Swanson Asher, Forester Nena, Kenye 9 Lydio Kurr, Ezra Nena, and Mackwelung Nena; and 10 WHEREAS, the late Nena S. Nena graduated from the Utwe Elementary School in 1964, hen went to Mizpah High School in Truk, Trust Tentory of the Pacific Islands in 1970; he then 12 went to college in the Phillipines at Silliman University where he graduated and earned his B.A.

13 degree in 1975, having been recognized as the first individual from Utwe Municipality and 14 among the few Kosraeans to have earned a bachelor's degree during that era; During the early 15 1980s, the late Nena S. Nena decided to further his education where he attended and graduated 16

from the University of Hawaii – Manoa with his Masters of Public Health & Administration

1	WHEREAS, after coming back from college in 1975, the late Nena S. Nena taught as a
2	Classroom Teacher at the Kosrae High School in Yekula from 1975 to 1977; in 1977, the late
3	Nena S. Nena served as a representative for the Utwe Municipality in the First Kosrae
4	Legislature, Kusaie District, TTPI; during the same period, he also served as a member of the
5	Education for Self-Government Task Force from 1977 to 1978; The longest part of his career
6	was from 1979 to 1991, when he served in numerous key positions at the Kosrae Department of
7	Health Services as the State Health Planner (July 1, 1979 - February, 1985), Administrative
8	Officer III (March 31, 1985 - March 30, 1995), and Acting Director (February, 1990/ May,
9	1990/ August, 1990); the late Nena S. Nena resigned from the Department of Health Services in
10	1995 after having been nominated and approved as the Director for the State Department of
11	Agriculture, Land, and Fisheries, notably so as the first resident from Utwe who held a key state
12	leadership position; After serving as Director for almost ten years, the late Nena S. Nena then
13 14	moved to Palikir, Pohnpei where he was nominated and approved as the Secretary for the FSM Department of Health & Social Affair, again holding a key calculate position from 2004 to 2007;
15	After working for the FSM National Government, he then became the Administrator for the FSM
16	National Health Care Plan (MiCare) from 2008 until his official retirement in 2016; and
17	WHEREAS, during his 41 years of dedicated service to the State and Nation, the late
18	Nena S. Nena was also known to hold other key public service capacities, which included
19	serving as the Floor Leader of the First Kosrae State Constitutional Convention in the 1980s,
20	serving as the Chairman of the Board of Directors for the very first utility corporation organized

1	and known today as Kosrae Utility Authority (KUA) during the 1990s, and serving as the
2	Chairman of the 1st, 2nd, and 3rd Utwe Municipality Charter Commissions; and
3	WHEREAS, the late Nena S. Nena is survived by his wife Elinora Sigrah Likiak of Lelu,
