A BILL FOR AN ACT

CON

To further amend State Law 11-171, as amended by State Law 12-04, by amending funding appropriated under Sections 1, 2(1), 2(17), 2(18), 2(19), 2(20), 3, 4, 5, 6, 7, 8, 9, 10(2), 11, 12(3) and insert subsections 12(13) and 12(14) to include funding for the Micronesian Island Forum (MIF) and the Pacific Island Development Bank (PIDB; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

Section 1. Purpose. The purpose of this act is to appropriate funding for the operations of the 3rd

and 4th Quarters of the locally funded branches of the Kosrae State Government its agencies and various 2

3 programs for the fiscal year ending September 30, 2019.

4 Section 2. Amendment. State Law 11-171, as amended by State Law 12-04, is hereby further

amended at Sections 1, 2(1), 2(17), 2(18), 2(19), 2(20), 3, 4, 5, 6, 7, 8, 9, 10(2), 11, 12(3) and insert 5

6 subsections 12(13) and 12(14) to include funding for the Micronesian Island Forum (MIF) and the

Pacific Island Development Bank (PIDB), as follows: 7

The sum of \$6,718,289or so much 8 9 thereof as may be necessary, is appropriated from the Amended Compact Fund; the sum of 10 \$694,305870,731, or so much thereof as may be necessary, is appropriated from the State Revenue Fund; the sum of \$960,374, or so much thereof as may be necessary, is appropriated from the United 11 12 States Grant Fund; and the sum of \$476,272 382,246, or so much thereof as may be necessary, is appropriated from the Foreign Assistance Fund for the operation of the Executive Branch for the fiscal 13 year ending September 30,2019. 14
