A RESOLUTION

WHEREAS, pursuant to Section 12 of Article V of the Kosrae State Constitution, the 1 Governor has the constitutional authority to appoint members comprising States Boards, 2 Authority, Commissions or Agencies with the advice and consent of the Legislature: and 3 WHEREAS, Section 7.1701 of title 7 of the Kosrae State Code established the Price 4 Control Commission to protect the people of Kosrae from price exploitation; and 5 6 WHEREAS, Section 7.1704 (1) and (2) of title 7 of the KSC to be composed of five 7 members appointed by the Governor with the advice and consent of the Legislature. The 8 members appointed shall be citizens residing in Kosrae State. The members appointed shall not 9 include more than one person having a controlling ownership or a managerial interest in one or more businesses in Kosrae. The Director of the Department of Administration and Finance shall 10 be an ex-officio member of the Commission, without the right to vote. The the term of office of 11 the appointed members of the Commission shall be two years. Appointments to fill vacancies 12
