

**A BILL FOR AN ACT**

To appropriate the sum of \$8,000.00 from the Revenue Fund of the Kosrae State Treasury to provide supplemental funding for the upcoming 2023 September Festivities in all respective municipalities; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$8,000.00 is hereby appropriated from the  
2 Revenue Fund of the Kosrae State Treasury to provide supplemental funding for the  
3 upcoming 2023 September Festivities in all respective municipalities; and for other  
4 purposes.

5 Section 2. Apportionment. The total amount shall be appropriated as follows:

6	1. Utwe	\$2,000.00
7	2. Malem	\$2,000.00
8	3. Lelu	\$2,000.00
9	4. Tafunsak	\$2,000.00
10		Total: \$8,000.00

11 Section 3. Allottee and lapsed date. All funds appropriated by this act shall be  
12 allotted, managed, administered, and accounted for in accordance with applicable laws.  
13 The allottee of the fund appropriated shall be the Governor of the State of Kosrae, who  
14 shall be responsible for ensuring that these funds, or so much thereof as may be  
15 necessary, are used for the purpose for which are appropriated and that no obligations are  
16 incurred in excess of the sum appropriated.

17 Section 4. Effective Date. This act takes effect upon the approval of the Governor  
18 or upon its becoming law without such approval.




