## A RESOLUTION

10	board members shall be members of the private sector whose primary occupations are in the
11	tourism industry. The Board of Directors shall serve a term of four years each; and
12	WHEREAS, by Governor Message No. 12-95, Honorable Governor Carson K. Sigrah
13	has re-nominated Mr. Emilson O. Phillip to be a member of the Kosrae Visitors Bureau
14	(Tourism) Board of Directors; and
15	WHEREAS, the Standing Committees on Resources and Development (R&D) has been

assigned to work on the re-nomination and has concluded its work on the re-nomination of Mr.

Emilson O. Phillip to the Kosrae Visitors Bureau Board of Directors; and
