#### A BILL FOR AN ACT

To amend the Kosrae State code by modifying Section 13.517(1) of the Kosrae State Code to include the possession of open container of alcoholic drinks on Sunday.

## BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

Section 1. Purpose. The purpose of this act is to amend the Kosrae State code by 1 2 modifying section 13.517(1). 3 Section 2. Amendment. Title 13, Chapter 5, Section 13.517(1) of the Kosrae State Code is hereby amended to read as follows: 4 5 "Section 13.517. Unauthorized consuming, possessing or giving of alcoholic drink. Unauthorized consuming, possessing or giving of alcoholic 6 drink is any of the following acts: 7 (1) 8 Consuming alcoholic drink or possessing an open container of 9 alcoholic drink on Sunday, Gospel Day or the day on which it is 10 celebrated pursuant to Section 2.501(3), or on December 25; 11 **(2)** Consuming or possessing alcoholic drink without attaining twenty-12 one years of age; 13 (3) Giving or selling alcoholic drink to a minor; 14 (4) Consuming an alcoholic drink or possessing an open container of 15 alcoholic drink in a public place except when such place is closed to 16 the general public for the purpose of conducting a private party,
