



A BILL FOR AN ACT

To appropriate the sum of \$70,000.00 from the Foreign Assistance Fund of the Kosrae State Treasury for the purpose of subsidizing the Kosrae State Public Safety overtime budget through the Joint Law Enforcement Agreement (JLEA) program; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1	Section 1. Appropriation. The sum of \$70,000.00 is hereby appropriated from the
2	Foreign Assistance Fund of the Kosrae State Treasury for the purpose of subsidizing the
3	Kosrae State Public Safety overtime budget through the JLEA program.
4	Section 2. Allotte and Lapse Date. All funds appropriated by this act shall be
5	allotted, managed, administered and accounted for in accordance with applicable laws.
6	The allottee of the funds appropriated shall be the Governor of the State of Kosrae, who
7	whall be responsible for ensuring that these funds, or so much thereof as may be
8	necessary, are used for the purpose for which they are appropriated and that no obligations
9	are incurred in excess of the sum appropriated. The authority of the allottee to obligate
10	funds appropriated by this act shall continue until expended.
11	Section 3. Effective Date. This act takes effect upon the approval of the Governor
12	or upon its becoming law without such approval.
