A BILL FOR AN ACT

To further amend State Law No. 12-190, as amended by State Law No. 13-07, by amending Section 4 at subsection (d) to modify the Kosrae State Legislature’s approved budget for Consumables (OCE); and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Purpose. The purpose of this Act is to amend State Law No. 12-190, as
2 further amended by State Law No. 13-07, by amending Section 4 at subsection (d) to
3 modify the Kosrae State Legislature’s approved budget for Consumables (OCE) under
4 Local Revenue; and for other purposes.

5 Section 2. Amendment. State Law No. 12-190, Section 4 at subsection (d) is
6 hereby amended to read as follows:

7 “Section 4. Apportionment. Operation of the Legislature. The sums apportioned by
8 Section 3 of this Act are apportioned as follows: ...

16 Section 3. Effective Date. This Act takes effect upon the approval of the Governor
17 or upon its becoming law without such approval
