A RESOLUTION

Amending Rule 4.2.6 (C) of the Kosrae State Legislature Rules of Procedures, by inserting a new subject, namely Kosrae Community Health Center, as of the subjects that fall within the jurisdiction of the Standing Committee on Health and Social Affairs.

1 **WHEREAS**, Rule 4.2.6 (C) of the Kosrae Legislature Rules of Procedure is
2 proposed to be amended to read as follows:

3 **“C. The Standing Committee on Health and Social Affairs.** The Committee
4 has jurisdiction and oversight of all matters pertaining to bills, resolutions, and
5 other matters referred to it, including Governor’s nominations submitted to the
6 Speaker during a session, which nominations require the advice and consent of
7 the Legislature, pertaining to physical and natural environment, physical and
8 mental health of the general public; public welfare; social security and general
9 well-being of the people of the State of Kosrae; and any other related subjects. It
10 shall be the duty of this committee to consider, investigate, or recommend needed
11 revisions of existing laws or new legislation relating to any subject matter within
12 its jurisdiction.

13 The committee shall be responsible for reviewing specific subjects, in the budget
14 of the Governor, and all supplemental thereto which make a request for an
15 appropriation that relates to a subject matter within its jurisdiction. Pursuant to its
16 review the committee shall recommend whether the matters referred to it, or
17 portions thereof, will be authorized, and if so, in what amount. Following its
18 review the committee shall promptly report its recommendation to the

1 Legislature. Those subjects which fall within the jurisdiction of the Committee
2 include, but are not limited to, the following:

- 3 1. The Department of Health Services
4 2. The Sports Council
5 3. Kosrae Community Health Center"; and

6 **WHEREAS**, the Members of the Legislature see it essential to include Kosrae
7 Community Health Center as a subject under the jurisdiction of the Standing Committee
8 on Health and Social Affairs; **NOW THEREFORE**;

9 **BE IT RESOLVED**, that this Twelfth Kosrae State Legislature, on its first
10 regular session, February 2019, hereby endorse proposed amendment as intended; and

11 **BE IT FURTHER RESOLVED**, that a certified copy of this resolution be
12 transmitted to the Honorable Carson K. Sigrah, Governor of the State of Kosrae.
