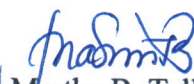

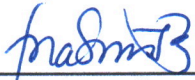

L. B. No. 13-193 L.D.1

A BILL FOR AN ACT

To appropriate the sum of \$6,000.00 from the Local Revenue Fund of the Kosrae State Treasury for the fiscal year ending September 30, 2025 for the purpose of providing funding support to the upcoming Kosrae Goodwill Games, slated for June, 2025; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$6,000.00 is hereby appropriated from the Local
2 Revenue Fund of the Kosrae State Treasury for the fiscal year ending September 30, 2025 for the
3 purpose of providing funding support to the upcoming Kosrae Goodwill Games, slated for June,
4 2025.

5 Section 2. Apportionment. The amount shall be apportioned as follows:

6 (1) Kosrae Goodwill Games(Welcome/Farewell Receptions) \$6,000.00

7 Section 3. Allottee and Lapse Date. All funds appropriated by this act shall be allotted,
8 managed, administered and accounted for in accordance with applicable laws. The allottee of
9 the fund appropriated shall be the Governor of the State of Kosrae, who shall be responsible for
10 ensuring that these funds, or so much thereof as may be necessary, are used for the purpose for
11 which are appropriated and that no obligations are incurred in excess of the sum appropriated.

12 Section 4. Effective Date. This act shall become law upon approval by the Governor or
13 upon its becoming law without such approval.

14 PASSED BY THE 13TH KOSRAE STATE LEGISLATURE ON THE 14TH DAY OF MAY,
15 2025.

ARTICLE IV

To appropriate the sum of \$6,000,000 from the General Fund of the Kosrae State Treasury for the fiscal year ending September 30, 2022 for the purpose of providing funding to the Kosrae Goodwill Games and other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE:

- 1 Section 1. Purpose. The sum of \$6,000,000 is hereby appropriated from the Fiscal
- 2 Revenue Fund of the Kosrae State Treasury for the fiscal year ending September 30, 2022 for the
- 3 purpose of providing funding to the upcoming Kosrae Goodwill Games slated for June
- 4 2022.
- 5 Section 2. Administration. The amount shall be apportioned as follows:
- 6 (1) Kosrae Goodwill Games (Welcome/Welcome Reception) \$6,000,000
- 7 Section 3. Effective Date and Fiscal Year. All funds appropriated by this act shall be allocated
- 8 managed, administered, and accounted for in accordance with applicable laws. The officer of
- 9 the fund appropriated shall be the Governor of the State of Kosrae who shall be responsible for
- 10 ensuring that these funds are used for the purpose for which they are appropriated.
