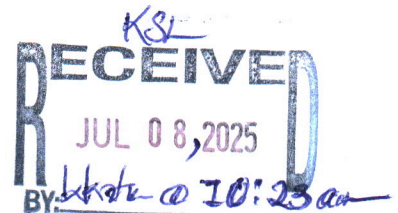

A BILL FOR AN ACT

To appropriate the sum of \$22,000.00 from the Local Revenue Fund of the Kosrae State Treasury for the fiscal year ending September 30, 2025 for the purpose of providing funding assistance to the 2025 Liberation Celebrations for the four municipal governments in the State of Kosrae; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$22,000.00 is hereby appropriated from the Local
2 Revenue Fund of the Kosrae State Treasury for the fiscal year ending September 30, 2025 for the
3 purpose of providing funding assistance to the 2025 Liberation Celebrations for the four
4 municipal governments in the State of Kosrae.

5 Section 2. Apportionment. The amount shall be apportioned as follows:

6	(1) Lelu Town Government	\$6,000.00
7	(2) Tafunsak Municipal Government	\$6,000.00
8	(3) Malem Municipal Government	\$5,000.00
9	(4) Utwe Municipal Government	\$5,000.00

10 Section 3. Allottee and Lapse Date. All funds appropriated by this act shall be allotted,
11 managed, administered and accounted for in accordance with applicable laws. The allottee of
12 the fund appropriated shall be the Governor of the State of Kosrae, who shall be responsible for
13 ensuring that these funds, or so much thereof as may be necessary, are used for the purpose for
14 which are appropriated and that no obligations are incurred in excess of the sum appropriated.

AN ACT

To appropriate the sum of \$22,000,000 from the Local Revenue Fund of the State Treasury for the fiscal year ending September 30, 2022 for the purpose of providing assistance to the 2022 Liberation Celebrations for the four municipalities in the State of Kansas and for other purposes.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF KANSAS:

- 1 Section 1. Appropriation. The sum of \$22,000,000 is hereby appropriated from the Local
- 2 Revenue Fund of the State Treasury for the fiscal year ending September 30, 2022 for the
- 3 purpose of providing funding assistance to the 2022 Liberation Celebrations for the four
- 4 municipalities in the State of Kansas.
- 5 Section 2. Appropriation. The amount shall be appropriated as follows:
- 6 (1) Esch Town Government \$2,000,000
- 7 (2) Fairbank Municipal Government \$2,000,000
- 8 (3) Holton Municipal Government \$2,000,000
- 9 (4) Linn Municipal Government \$2,000,000
- 10 Section 3. Allotment and Disbursement. All funds appropriated by this act shall be allotted,
- 11 managed, administered and accounted for in accordance with applicable laws. The allotment of
- 12 the fund appropriated shall be the discretion of the Governor of the State of Kansas, who shall be responsible for
- 13 ensuring that these funds are used for the purpose for
- 14 which are appropriated and that no obligations are incurred in excess of the amount appropriated.






