A BILL FOR AN ACT

To amend State Law No. 12-26, to further amend Title 9 at Section 9.2102 of the Kosrae State Code, by modifying the collection and receiving of the \$5 fee to the Kosrae State Treasury, from quarterly to bi-weekly basis; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

Section 1. Purpose. The purpose of this act is to amend State Law No. 12-26, to

2 further amend Section 9.2102 of Title 9 of the Kosrae State Code, by modifying the

3 collection and receiving of the \$5 fee to the Kosrae State Treasury, from quarterly to bi-

4 weekly basis; and for other purposes.

Section 2. Amendment. Title 9, Chapter 21, Section 9.2102 of the Kosrae State

Code is hereby amended to read as follows:

7 "Section 9.2102. Airport Utilization Fee. Each passenger departing from the

8 Kosrae International Airport to any destination outside Kosrae State pays an Airport

9 Utilization Fee of \$20.00. The fee is paid by or on behalf of each passenger and is

collected by the Director upon the passenger's departure from the State at the Kosrae

International Airport Terminal. The passenger does not have the right to depart from

12 Kosrae International Airport until the Airport Utilization Fee is received by the Director.

13 The Director may provide by regulation, procedures for the efficient collection and

handling of Airport Utilization Fee moneys, including the imposition of fines not to

exceed \$50.00 for the failure or refusal of any passenger to pay the Airport Utilization

16 Fee. Provided that \$5.00 from every paid Airport Utilization Fee shall be deposited into

or upon its becoming law without such approval.

the Kosrae State Treasury. Payment to the Kosrae State Treasury from amount collected and received shall be made on a quarterly bi-weekly basis from effective date or until 2 prescribed otherwise by law. Provided further, a quarterly report to the Governor and the 3 Legislature on the collection made by the Director of Administration and Finance, and to 4 appear, in person, before the Legislature when necessary. The Director of Administration 5 and Finance shall establish a separate account within the Kosrae State Treasury for the 6 amount received and collected." 7 Section 4. Effective Date. This act takes effect upon the approval of the Governor
