A RESOLUTION

Urging the Governor after he has set a date for the referendum on proposed amendments to the Kosrae State Constitution to include in the referendum ballot the following proposed amendment to the Constitution that Section 13 of Article V of the Constitution be amended so that the Governor can by decree temporarily suspend or amend any Kosraean State Law.

1 WHEREAS, members of the Twelfth Kosrae State Legislature perceive that it is 2 necessary to amend Section 13 of Article V of the Kosrae State Constitution to clarify and 3 amplify the extent of the operation of the Governor's powers when declaring a state of 4 emergency and when issuing appropriate decrees so that the preservation of peace, health or 5 safety can be more practically undertaken overall; 6 WHEREAS, members of the Twelfth Kosrae State Legislature further perceive that it is 7 appropriate that to avoid doubt: Section 13 of Article V of the Kosrae State Constitution be 8 amended as follows: After the word "decrees" add the following phrase: 'which may include the 9 temporary suspension or amendment of any Kosrae State Laws which the Governor reasonably 10 sees fit to do so.' By inserting between the words "right" and "to" the following phrase: "or 11 may temporarily suspend or amend any Kosrae State Law": NOW AND THEREFORE 12 **BE IT RESOLVED**, by members of the Twelfth Kosrae State Legislature propose 13 pursuant to Article XV Section 1 of the Kosrae State Constitution that the existing Section 13 of 14 Article V of the Kosrae State Constitution which reads "If required to preserve the public peace." 15 health, or safety, at a time of extreme emergency caused by civil disturbance, natural disaster, or immediate threat of war or insurrection, the Governor may declare a state of emergency and 16
