A BILL FOR AN ACT

To appropriate the sum of \$2,500.00 from the Revenue Fund of the Kosrae State Treasury for the fiscal year ending September 30, 2026 for the purpose of providing funding assistance for the General Election scheduled to be held in the Lelu Town Government in November, 2025; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$2,500.00 is hereby appropriated from the
2 Revenue Fund of the Kosrae State Treasury for the fiscal year ending September 30, 2026
3 for the purpose of providing funding assistance for the General Election scheduled to be
4 held in the Lelu Municipal Government in November, 2025.

5 Section 2. Allottee. All funds appropriated by this act shall be allotted, managed,
6 administered, and accounted for in accordance with applicable laws. The allottee of the
7 funds appropriated shall be the Governor of the State of Kosrae, who shall be responsible
8 for ensuring that these funds, or so much thereof as may be necessary, are used for the
9 purpose for which are appropriated and that no obligations are incurred in excess of the
10 sum appropriated.

11 Section 3. Effective Date. This act takes effect upon the approval of the Governor
12 or upon its becoming law without such approval.

14 OCTOBER, 2025.
