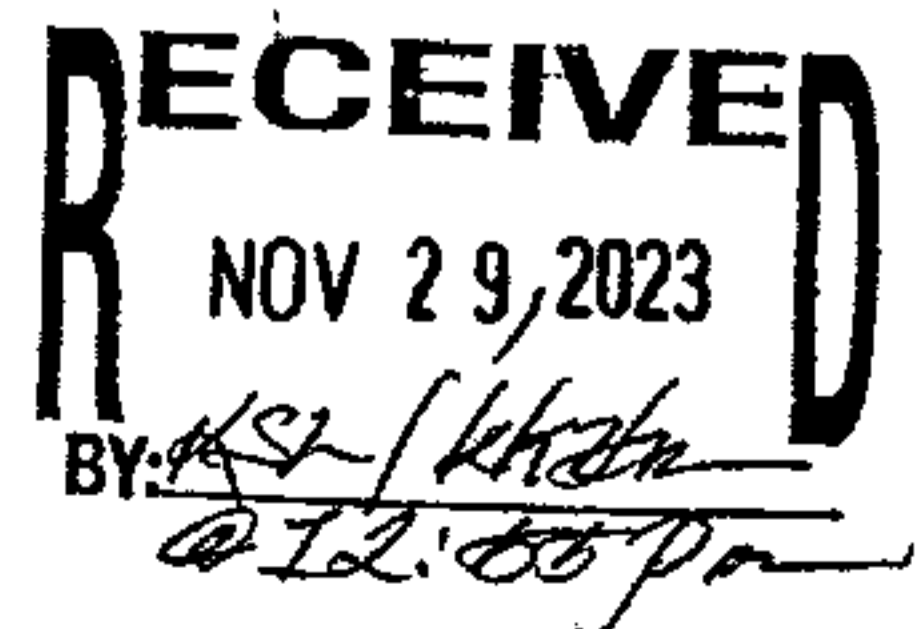

A BILL FOR AN ACT

To appropriate the sum of \$15,000 from the Revenue Fund of the Kosrae State Treasury for the purpose of providing funding assistance for the 2023 Women’s Conference to be held in the State of Kosrae; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$15,000 is hereby appropriated from the
2 Revenue Fund of the Kosrae State Treasury for the purpose of providing funding
3 assistance for the 2023 Women’s Conference to be held in the State of Kosrae.

4 Section 2. Apportionment. The amount appropriated in Section 1 of this act is
5 apportioned as follows:

- 6 1. Kosrae Women’s Association \$15,000

7 Section 3. Allottee. All funds appropriated by this act shall be allotted, managed,
8 administered, and accounted for in accordance with applicable laws. The allottee of the
9 funds appropriated shall be the Governor of the State of Kosrae, who shall be responsible
10 for ensuring that these funds, or so much thereof as may be necessary, are used for the
11 purpose for which are appropriated and that no obligations are incurred in excess of the
12 sum appropriated.

13 Section 4. Effective Date. This act takes effect upon the approval of the Governor
14 or upon its becoming law without such approval.
