

A BILL FOR AN ACT

To amend State Law No. 12-190, by amending Section 4 at subsection (c) to modify the Kosrae State Legislature’s approved budget for Contractual; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Purpose. The purpose of this Act is to amend State Law No. 12-190, by
 2 amending Section 4 at subsection (c) to modify the Kosrae State Legislature’s approved
 3 budget for Contractual under Local Revenue; and for other purposes.

4 Section 2. Amendment. State Law No. 12-190, Section 4 at subsection (c) is
 5 hereby amended to read as follows:

6 “Section 4. Apportionment. Operation of the Legislature. The sums
 7 apportioned by Section 3 of this Act are apportioned as follows: ...

14 Section 3. Effective Date. This act takes effect upon the approval of the Governor
 15 or upon its becoming law without such approval.
