L.B. No. 13-229

A BILL FOR AN ACT

To appropriate the sum of \$250,000 from the US Federal Grant of the Kosrae State Treasury for the purpose of funding Kosrae State Office of Administration and Finance – Single Audit Assistance – TAP Grant D25AP00419; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The amount of \$250,000 from the US Federal Grant of the Kosrae
2 State Treasury for the purpose of funding Kosrae State Office of Administration and Finance – Single
3 Audit Assistance – TAP Grant D25AP00419.

4 Section 2. Allottee and Lapse Date. All funds appropriated by this act shall be allotted,
5 managed, administered and accounted for in accordance with applicable laws. The allottee of the
6 funds appropriated shall be the Governor of the State of Kosrae, who shall be responsible for ensuring
7 that these funds, or so much thereof as may be necessary, are used for the purpose for which are
8 appropriated and that no obligations are incurred in excess of the sum appropriated. The authority of
9 the allottee to obligate funds appropriated by this act shall lapse on September 30, 2027.

10 Section 3. Effective Date. This act shall become law upon approval by the Governor or upon
11 its becoming law without such approval.
