A BILL FOR AN ACT

To appropriate the sum of \$48,540.00 from the U.S. Federal Grant Fund of the Kosrae State Treasury for the purpose of funding the Kosrae FY22 HPF/Operation and HPF Subgrant/Contract/Special Project in the State of Kosrae; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1           Section 1. Appropriation. The sum \$48,540.00 from the U.S. Federal Grant Fund of the Kosrae  
2 State Treasury for the purpose of funding the Kosrae FY22 HPF/Operation and HPF  
3 Subgrant/Contract/Special Project in the State of Kosrae.

4           Section 2. Apportionment. The sum of \$48,540.00 of the U.S. Federal Grant is hereby  
5 apportioned as follows:

| 7 | 2. FY22 HPF/SubGrant/Contract/Special Project | - | \$8,500.00  |

8           Section 3. Allottee and Lapse Date. All funds appropriated by this act shall be allotted,  
9 managed, administered and accounted for in accordance with applicable laws. The allottee of the fund  
10 appropriated shall be the Governor of the State of Kosrae, who shall be responsible for ensuring that  
11 these funds, or so much thereof as may be necessary, are used for the purpose for which are appropriated  
12 and that no obligations are incurred in excess of the sum appropriated.

13           Section 4. Effective Date. This act shall become law upon approval by the Governor or upon its  
14 becoming law without such approval.




