

A BILL FOR AN ACT

To appropriate the sum of \$16,000 from the Local Revenue Fund of the Kosrae State Treasury to subsidize the operation of the Utwe Water System; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$16,000 is hereby appropriated from the
2 Local Revenue of the Kosrae State Treasury to subsidize the operation of the Utwe Water
3 System.

4 Section 2. Apportionment. The amount appropriated in Section 1 of this act is
5 apportioned as follows:

6 1. Utwe Water System Operation	\$16,000
----------------------------------	----------

7 Section 3. Allottee. All funds appropriated by this act shall be allotted, managed,
8 administered, and accounted for in accordance with applicable laws. The allottee of the
9 funds appropriate shall be the Governor of the State of Kosrae, who shall be responsible
10 for ensuring that these fund, or so much thereof as may be necessary, are used for the
11 purpose for which are appropriate and that no obligations are incurred in excess of the sum
12 appropriated.

13 Section 4. Effective Date. This act takes effect upon the approval of the Governor
14 or upon its becoming law without such approval.
