A BILL FOR AN ACT

To amend State Law 13-90, to extend the lapse date of the FY2023 HPF/SHPO project in the State of Kosrae; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Purpose. The purpose of this amendment is to amend the lapse date of the
2 FY2023 HPF/SHPO project in the State of Kosrae.

3 Section 2. Amendment. State Law No. 13-90 is hereby amended at Section 3 to read as
4 follows:

5 3. Allottee and Lapse Date. All funds appropriated by this act shall be allotted,
6 managed, administered and accounted for in accordance with applicable laws. The allottee
7 of the fund appropriated shall be the Governor of the State of Kosrae, who shall be
8 responsible for ensuring that these funds, or so much thereof as may be necessary, are used
9 for the purpose for which are appropriated and that no obligations are incurred in excess of
10 the sum appropriated. The authority of the allottee to obligate funds appropriated by this
11 act shall lapse on April 15, 2027.

12 Section 4. Effective Date. This act shall become law upon approval by the Governor or
13 upon its becoming law without such approval.
