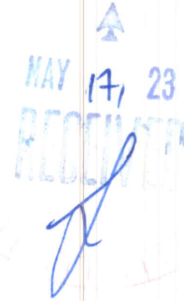

A BILL FOR AN ACT

To appropriate the sum of \$3,300 from the Revenue Fund of the Kosrae State Treasury for the purpose of funding the upcoming State Leadership's community visits/ outreach in support of the proposed FSM constitutional amendments; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$3,300 is hereby appropriated from the
2 Revenue Fund of the Kosrae State Treasury for the purpose of funding the State
3 Leadership's community visits/ outreach in support of the proposed FSM constitutional
4 amendments; and for other purposes.

5 Section 2. Apportionment. The amount appropriated in Section 1 of this act is
6 apportioned as follows:

7	1. Lelu community outreach	\$800
8	2. Malem community outreach	\$700
9	3. Utwe community outreach	\$700
10	4. Tafunsak community outreach	\$700
11	5. Walung community outreach	\$400

12 Section 3. Allottee. All funds appropriated by this act shall be allotted, managed,
13 administered, and accounted for in accordance with applicable laws. The allottee of the
14 funds appropriated shall be the Governor of the State of Kosrae, who shall be responsible
15 for ensuring that these funds, or so much thereof as may be necessary, are used for the
16 purpose for which are appropriated and that no obligations are incurred in excess of the
17 sum appropriated.


