16 bank until 2008, when he was again promoted to Loan Officer; In 2009, Mr. Greg S. George
17 applied with the newly transferred Bank of Guam (BOG) and got recruited to the position of

1 Operation Officer I, a position he held for the next ten years; Later in November of 2019, Mr.
2 Greg S. George was once again promoted to Operation Officer II for a year; and

4 S. George was notified of his new appointment as Branch Manager for the Bank of Guam –


