

A BILL FOR AN ACT

To appropriate the sum of \$500.00 from the Revenue Fund of the Kosrae State Treasury for the purpose of funding the APIL 2023 ; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1           Section 1. Appropriation. The sum of \$500.00 is hereby appropriated for the Revenue  
2 Fund of the Kosrae State Treasury for the purpose of funding the APIL 2023.


3           Section 2. Allottee and Lapse Date. All funds appropriated by this act shall be allotted,  
4 managed, administered and accounted for in accordance with applicable laws. The allottee of the  
5 funds appropriated shall be the Speaker of the State of Kosrae, who shall be responsible for  
6 ensuring that these funds, or so much thereof as may be necessary, are used for the purpose for  
7 which are appropriated and that no obligations are incurred in excess of the sum appropriated.  
8 The authority of the allottee to obligate funds appropriated by this act shall be until expended.

9           Section 3. Effective Date. This act shall become law upon approval by the Governor or  
10 upon its becoming law without such approval.
